#### Cause 1:

LYNX Aluminum Profiles

LYNX expressly warrants that its product line is free from manufacturing defects in material or workmanship.

When Siding and Cladding is applied according to LYNX installation guides and properly maintained, such product is guaranteed against the following:

## The aluminum profile is warranted for 50 years against:

- 1. Buckling: LYNX Siding and Cladding will be free of any buckling, that is not associated with the substrate and/or structure to which LYNX is attached. For the purpose of this warranty, buckling shall be defined as warping of the product exceeding 1/16" out of plane per linear foot.
- Corrosion: LYNX Siding and Cladding is guaranteed against rust and corrosion. Subject to the limitations set out in
- Delamination: No delamination of the product finish on the building Subject to the limitations set out in Clause 2

## The film finish is warranted for 25 years against:

- 1. Fading: A QUV test of 10,000 hours with a total exposure of 20 GJ/m² was conducted, resulting in a Gray Scale rating of 4-5. This corresponds to a ΔE of approximately 1-3, meaning color change is minimal and barely perceptible under normal viewing conditions.
- Peeling, flaking, blistering, or cracking of the film layer.
- Our commitment: If, during the Limited Warranty Period on the LYNX Aluminum Profiles, the product is defective in material or workmanship, LYNX will either repair or replace the defective portion of the Lynx Siding and Cladding.

If, during the Limited Warranty Period on the finish film, the product is defective in material or workmanship, LYNX will either repair or replace the defective portion of the Lynx Siding and Cladding.

After 25 years this Limited warranty on the finish film and after 50 years on the LYNX Aluminum Profiles will expire and shall no longer be applicable.

LYNX replacement of the defective product or reimbursement of this Limited Warranty is the exclusive remedy for the Covered Person for any defect in materials or workmanship. The company will not refund or pay any costs in connection with labor or accessory materials.

### Clause 2:

a. This warranty will not extend or cover:

- b. Damages to the coated metal caused by handling, shipping, processing and/or installation; or
- Damages to the coated metal caused by scratching or abrading after installation; or
- The warranty will not be applicable to damage or failure, which is caused by acts of God, falling objects, external forces, explosions, fire, riots, civil commotion's, acts of war, or other such similar or dissimilar occurrences beyond The Company's control.
- e. Customer shall make available to The Company the dates of the installation of the coated metal, the maintenance records including details of washing and cleaning procedures. Customers shall demonstrate that the failure of the coated metal was due to a breach of the warranty stated herein.
- Claims must be made in writing to LYNX within 30 days of the discovery of a problem and authorization obtained prior to beginning any repair work. After receiving such notice, The Company must be given a reasonable opportunity to inspect and verify the claim.
- Color variance between replaced product and original shall not be indicative of a defect.

#### Clause 3:

- This warranty represents the entire agreement between parties in relation to its subject matter and supersedes any previous agreement whether written or oral between the parties in relation to its subject matter. The limited warranties state the entire liability of LYNX with respect to the products covered by them. The Company shall have no liability for any incidental or consequential damages. No person is authorized to make any representation or warranty on behalf of LYNX except as expressly set forth above, and any such statement shall not be binding on The Company. Except as expressly set forth above, LYNX makes no warranty of any kind, express or implied, including, without limitation, any implied warranty of merchantability or fitness for a particular purpose. Warranties shall be the duration of the limited warranty, or such shorter duration as provided under applicable local law. These limited warranties give you specific legal rights, and you may also have other rights which vary from area to area.
- Nothing in this warranty shall be construed as a warranty of the workmanship of any installer or as imposing on LYNX any liability for unsatisfactory performance caused by faulty workmanship in installation.
- Required Maintenance. On an annual basis use a soft sponge or cloth, water and mild detergent, non-abrasive soap with the pH range of 5-9 to clean the area of dirt, grime and other debris. Pressure washing and the use of harsh detergents or chemicals is not recommended.
- Registration of the product within 90 days of installation is required for this warranty to be valid. The warranty applies to the original purchaser and may be transferred once to a subsequent owner.
